## A message from the Pastor...

Happy New Year, 2025! Are you making any resolutions this year? If you are, how likely is it that you follow through for the whole year? How long did your resolutions last in the past? If you are like me and most people those resolutions don't last very long.

We are told that the New Year offers a fresh start, a clean slate. It is supposed to be a time to examine ourselves and think about those areas where we could make some improvement. Resolutions related to health are the most popular, diet, exercise, and stopping bad habits. Sometimes we promise to be nicer to others, particularly our loved ones. Sometimes it is about trying something new, expanding our horizons, like learning a foreign language, taking a woodworking class, or joining a book club. Always, though, the New Year's resolution is about becoming a better version of ourselves, a healthier, smarter, kinder version of who we are.

There is nothing wrong with pursuing self-improvement, however as followers of Jesus we do have to be careful. Jesus does not call his disciples with a command to "improve yourself." Jesus calls us to "follow him." Sometimes this can look like "self-improvement" from the outside if we are trying to break a bad habit or struggling against some frequent sin. The issue is "self-improvement" is always a promise we make to ourselves.

Life with Jesus is not a quest to become a better version of ourselves but journey of discipleship leading to a more Christ-like existence. We follow Jesus because we are responding to his sacrifice, mercy, and grace. Because he has called us and saved us, we seek to follow him. When we do this, we do it with Jesus, trusting in his promise, presence, and power in our lives. With a new year's resolution, we are on our own, accountable only to ourselves. In faith, we are never alone.

As disciples of Jesus, we follow his example and pattern of life, therefore our resolutions will focus on self-emptying not self-improvement, bettering others before bettering ourselves, and self-sacrifice instead of self-centeredness. Instead of vowing to go on a diet, we can calculate the money spent on junk food and snacks and use it to feed the hungry. Instead of focusing relentlessly on fitness, we can volunteer at the hospital and minister to the sick. Instead of resolving to be nicer to others, we pray that we may have the mind of Christ and see each person as Christ sees them.

Only Jesus can bring about the lasting changes for which we long. There is nothing wrong with resolving to eat better or exercise more, but too often those promises we make to ourselves become empty words. It's the promise God makes to us, the promise of new life through the self-giving obedience of Jesus that really counts.



#### Highlights from the August 27, 2024 Meeting:

- 1. Bob Borneman mentioned that the painting was completed. The bill was over budget by \$365. However, there was some damage to the walkway - the weight of the machine caused the bricks to concave. After talking to Butch, an estimate (\$1400) to repair the bricks was sent over to the painter. The remainder of the bill was paid after deducting the \$1400. The claim has been made through his insurance company and Butch will be the contact person with the insurance company to coordinate the repair of the walkway.
- 2. Pastor Finney and Bob talked about removing the front pew and half of the next one. Dave Fioriglio makes a motion to split pews as described by Bob, Roxanne seconded it. Motion passed.
- 3. Windstream/Kinetic Lease: transfer lease income to the endowment fund. Gerry Flicker makes a motion and is seconded by Dave Fioriglio. Motion passed.
- 4. Windstream wants to change the lease agreement: new term will be for five years with (3) 5-year options, which could extend the lease for 20 years with 3% annual escalation in monthly rent. Dave Fioriglio made a motion to accept the proposal and seconded by Roxanne Fox. Motion passed.
- 5. The Constitution will be available by October 1<sup>st</sup> for approval after Roxanne Fox and Dave Fioriglio review it.
- 6. Vitality Survey the planning committee will look into have the congregation takes a survey
- 7. Christian education can we do VBS here? It was decided to reignite Christian ed and then discuss VBS at a later date

#### **OLD BUSINESS:**

1. Property committee issues: Back stairs need to be marked for ADA acceptance

#### NEW BUSINESS:

1. The audio/AV system for the church: discussed needing a camera, a computer, wireless microphone system. It will need to be hardwired. The company has done a lot of business with other churches. There is no quote yet, more details to follow.

#### Highlights from the September 24, 2024 Meeting:

- 1. Damages to the walkway that were done by the painting company have been repaired. The church should pay the full amount and not withhold anything because we were made whole. We owe the balance based on his contract.
- 2. Technology committee: Dave Fioriglio talked about the idea of a system to enhance the audio and visual capabilities. The quote is a little higher than \$17,200 (does not include PC - an i5 and a TB). This includes a camera (won't be mounted on the balcony), mixing board, software, installation, and training. We will put it on the agenda for the next congregational meeting in November. The new system is digital and can operate on an iPad. It would be ideal to have three to four people trained on the new system as well as having the steps documented to ensure other members can be trained.
- 3. Date for the November congregational meeting is November 10<sup>th</sup>. It is usually the 2nd Sunday in November.
- 4. Salary and housing for Pastor Matt: He has been with us for four years and his last pay change was in 2021. A 3% increase on our share, health insurance will go up but not significantly. A motion was made by Roxanne Fox and seconded by Gerry Flicker to hold off on approving this until all the numbers are known by the next council meeting on October 22<sup>nd</sup>. Motion passed.
- 5. Constitution ready for approval at November Congregational meeting
- 6. Publicity form: Dave Fioriglio makes a motion to put a statement in the bulletin that we are taking visual images of everyone as they come and go. We will approve the specific statement at the next council meeting in October. Unless you sign a form, you are consenting to have your pictures taken and posted.
- 7. Windstream: Council has decided to leave it as is regarding the terms of the lease.
- 8. Terms on Church Council: Bob Heydt, Keith Folk, and Sue Hoffman are finishing at the end of 2024. Sue Hoffman is not eligible to serve again and Bob Heydt will serve again as long as another member becomes President.

#### Highlights from the October 22, 2024 Meeting:

- 1. Upper Montgomery Conference gathering on Tuesday, October 29th at 7pm at St. James Lutheran in Limerick: Bob Heydt is willing to go but would like another volunteer as well
- Budget review and approval: Last year at this time there was an approximate surplus of \$8,000 as compared to this year where we are behind about \$9,000. Usually there is a turn around between Thanksgiving and Christmas where donations increase. A motion was made to approve the budget by Roxanne Fox and seconded by Dave Fioriglio. Motion passed.
- 3. Church Council Nominations: Keith Folk, Bob Heydt and Marvin Steward are willing to serve another term. That leaves one position currently open.
- 4. Constitution and By-laws: Roxanne Fox, Dave Fioriglio, and Bob Heydt compared the constitution and model constitution; adopted the changes and created a draft document for approval at the next congregational meeting. A motion was made by Dave Fioriglio and seconded by Gerry Flicker to present the Constitution and By-Laws to the congregation for approval. Motion passed.
- 5. Technology committee Dave Fioriglio met with Diane, Denise and the Pastor to discuss the proposal. The PC and additional microphones would be purchased (one of the wireless mics will be taken over to the social hall). This shall not exceed \$20,000 (18,175.97) and includes tech support. Dave will ask about a warranty and financing would come from the memorial fund. A motion was made by Roxanne Fox and seconded by Gerry Flicker to present this information for approval at the next congregational meeting.
- 6. Windstream Lease: Amendment stipulating that, upon their decision to vacate, the premises will be returned to their original condition. Permission was granted to discuss the specifics through a phone conversation.

- Property Committee Report: still working on the list for the handicapped accessibility: the other half of the front pew has been removed; new lighting was installed in the parking lot on 10/11/24; looking at the gap between the elevator and the floor; reviewing how to mount the extra rail on the back stairs

#### Highlights from the November 26, 2024 Meeting:

#### 1) Date for December Council Meeting (4<sup>th</sup> Tuesday is Christmas Eve):

Pastor Matt is unavailable for a meeting on Tuesday 12/17. Council will meet on Monday 12/16 at 6:30pm. Snacks are welcome. Nomination of Officers for 2025 will take place at this meeting.

- 2) Identify additional name / nomination for term completed by Sue Hoffman: Bob thanked Sue Hoffman for her 6 years of service on Council and her work as Treasurer. As of now, there is no one to replace Sue on Council. Any person that would accept a nomination would be approved at the February Congregational meeting. Sue may continue on as church treasurer, as a non-council member.
- Finalize action on AV / Technology Upgrades: Audiobahn in Pottstown does mostly churches and many older churches. After some discussion, a motion was made by Roxanne Fox and seconded by Pat Moser to move ahead without another bid. Motion passed.
- 4) <u>Copier Service Contract Ending:</u> This is the stand-alone copier not the table top copier. Canon will no longer be producing spare parts for this model after June of 2025 so, our service contract will not be renewed.

We own the copier (purchased in 2017) and it has printed about 340,000 copies. There have been no service calls in the last year but there has been an occasional network issue in the past that has needed to be corrected.

Possible options were discussed.

- a) Use the printer without a service contract, some parts will still be in stock after June.
- b) Would a third party be willing to maintain obsolete equipment?
- c) Would leasing with usage charges be an option?
- d) Purchase a new printer.
- e) Switch to another vendor due to last minute notification.
- Dave F. will research possibilities.
